





# GENERAL INTRODUCTION TO EIT

- European Institute of Innovation and Technology, EIT
- Independent EU body established in March 2008
- Main aim: to strengthen Europe's ability to innovate
- Motto: Making innovation happen
- Originally financed directly from EU budget, since 2014 from FPs
- Integral part of Horizon Europe (Rules of Participation apply) NEW
- Strategic Innovation Agenda (SIA) 2021-2027 (official launch on 14 June 2021) NEW
- NCPs nominated in Spring 2021



# 5 STRATEGIC OBJECTIVES (SO) AND 10 ACTION PROGRAMMES (AP)



# **FIRST OPEN CALLS – PUBLISHED ON 3 APRIL 2023**

- The application system will open on 17 April and close on 31 May 2023 !
- Up to € 10.45 million in funding available for 2024
- An additional allocation of up to € 3.45 million is earmarked in 2025 for pluriannual projects
- All CCSI stakeholders and legal entities in the EU and Associated Countries to the Horizon Europe Programme are eligible to apply
- Almost half of the available funds are reserved for innovation projects with a clear and viable commercialisation plan
  - these proposals are expected to deliver innovative products, processes, services, or business models in the audiovisual and media, architecture, fashion and textile, design, and cultural heritage sectors.
- Opportunities for projects in higher education, business creation, and social Innovation are included as well
  - these proposals are expected to fund cultural and social entrepreneurship initiatives that demonstrate scalable social innovation pilots to address local-based challenges and contribute to social cohesion


