0. Introduction

This is a call for proposals for EU **action grants** in the field of Culture under the **Creative Europe Programme**.

The regulatory framework for this EU Funding Programme is set out in:

- Regulation 2024/2509 ([EU Financial Regulation](#))¹
- the basic act (Creative Europe Regulation [2021/818](#))².

The call is launched in accordance with the 2026 Work Programme³ and will be managed by the **European Education and Culture Executive Agency (EACEA)** ('Agency').

 Please note that this call is subject to the final adoption of the budget 2026 by the EU budgetary authority. In case there are substantial changes, we may have to modify the call (or even cancel it).

The call covers the following **topic**:

- **CREA-CULT-2026-PERFORM-EU – Perform EU**

1. Background

Creative Europe brings together actions supporting the European cultural and creative sectors.

The term '**cultural and creative sectors**' means all sectors whose activities are based on cultural values artistic and other individual or collective creative expressions. The activities may include the development, the creation, the production, the dissemination and the preservation of goods and services which embody cultural, artistic or other creative expressions, as well as education or management, related to these activities. Those sectors include, inter alia, architecture, archives, libraries and museums, artistic crafts, audio-visual (including film, television, video games and multimedia), tangible and intangible cultural heritage, design (including fashion design), festivals, music, literature, performing arts, books and publishing, radio, and visual arts.

The **general objectives of the Programme** are:

- to safeguard, develop and promote European cultural and linguistic diversity and heritage;
- to increase the competitiveness and the economic potential of the cultural and creative sectors, in particular the audio-visual sector.

The objectives of the Programme take into account the dual nature of the cultural and creative sectors, recognising, on the one hand, the intrinsic and artistic value of culture and, on the other, the economic value of those sectors, including their broader contribution to growth and competitiveness, creativity and innovation. The objectives

are pursued in a way that encourages inclusion, equality, diversity and participation, including, where appropriate, specific incentives that encourage the active participation in the cultural and creative sectors of people with disabilities, people belonging to minorities and people belonging to socially marginalised groups, including both the creative process and audience development; and gender equality, in particular as a driver of economic growth, innovation and creativity.

EU values being at the core of the EU programmes, beneficiaries and activities implemented within actions of the Creative Europe Programme have to respect the EU values, as reflected in Article 2 of the Treaty on European Union, and the rights and principles enshrined in the Charter of Fundamental Rights of the European Union, particularly Article 21: respect of human dignity, freedom, democracy, equality, rule of law, respect for human rights, non-discrimination based on sex, race, ethnic or social origins, genetic features, language, religion or belief, political or any other opinion, membership of a national minority, property, birth, disability, age or sexual orientation.

CREATIVE EUROPE CONTRIBUTION TO OVERARCHING EU PRIORITIES

The cultural and creative sectors are facing several overarching challenges triggered inter alia by the current volatile context and geopolitical instability, including the Russian war of aggression in Ukraine.

The priorities of the European Commission provide a special role for culture in protecting democracy, boosting societal resilience, upholding values and safeguarding the rule of law.

The actions of the Programme will as well contribute to the implementation of high-level initiatives, such as the European Green Deal and the New European Bauhaus.

Digital transition

The way in which cultural content is created, produced, distributed, and disseminated is increasingly digital.

Digital technologies and the acceleration of generative artificial intelligence offer new opportunities but also poses challenges for the cultural and creative sectors. The deployment of AI models shall be carried out in full respect of EU law, including AI act and copyright legislation. The provisions included in the Artificial Intelligence Act will support the enforcement of the EU copyright rules for the training of general-purpose AI models and will increase transparency about the training content. Furthermore, AI generated content will have to be labelled as such.

Meanwhile, artists, cultural professionals, and creative organisations and companies must prepare to take advantage of the new opportunities emerging from AI. Creative Europe funding will be a catalyst for the sector to take up new technologies, while addressing the related challenges and risks.

The Programme, and the projects it finances, will be implemented in line with the values enshrined in the European Declaration on Digital Rights and Principles, which promotes a sustainable, human-centric vision for the digital transition.

Strengthening the green transition - Creative Europe contribution to the EU Greening efforts

In 2026, the Commission will continue looking into ways how environmental, sustainable and proportional measures can be effectively and efficiently introduced in

Creative Europe actions and funded initiatives, addressing the objectives of the European Green Deal, while respecting the core values of the Programme.

This work will continue to be based on the results of the study "[Greening the Creative Europe Programme](#)" (2023), particularly the "Creative Europe Programme Greening Strategy"⁴ included there and the document on "[Quality Assessment of Green Aspects in Creative Europe Projects \(Culture strand\)](#)"⁵ (2024), but also on the recommendations of the Open Method of Coordination (OMC) group of experts from both cultural and environmental-climate policies, expected in the second half of 2025.

The Commission (DG EAC) will also continue supporting the network of Green Contact Points in Creative Europe Culture Desks to share good practices and build the capacity of all stakeholders engaged in the implementation of the Culture strand of the Programme.

Inclusion and gender equality

Inclusion and gender equality remain at the heart of the Creative Europe Programme, meaning that funded projects must address those topics in the design and implementation phases.

In this way, projects under the Creative Europe Programme will contribute to the [Commission equality and inclusion strategies under the Union of Equality policy framework](#), contributing and reporting its actions on gender equality, anti-racism and fighting antisemitism, Roma strategic framework for equality, inclusion and participation, LGBTIQ equality and rights of persons with disabilities.

International relations

Following the illegal full-scale invasion of Ukraine by Russia, Creative Europe will continue supporting Ukrainian artists and cultural operators in showcasing their work and supporting the Ukrainian displaced population in accessing culture in these extremely challenging times. Furthermore, the Programme, and the projects it finances, promote capacity-building within the European cultural and creative sectors, including grassroots organisations and micro-organisations, so that they are able to be active at the international level.

2. Objectives — Themes and priorities — Activities that can be funded — Expected impact

Objectives

The specific objective of this action is to test and implement innovative models through changemaker projects, to rethink touring in the performing arts in a more sustainable, inclusive, diverse and balanced way.

This action addresses applicants that are active in the performing arts sector and have a high sectorial, sub-sectorial representativity and geographical coverage.

Themes and priorities (scope)

In line with the current cultural policy priorities, applicants should propose a project contributing to:

1. Overarching EU priorities (as described in section 1. Background).

Applicants must describe in their application how, in the design and implementation of their project, they intend to contribute to the EU's efforts in terms of greening and digital transitions and respond to the priorities of inclusion and gender equality as well as the international dimension and in the case of this call to support performing arts sector, its sub-sectors through projects involving Ukrainian artists, cultural professionals and organisations working in the performing arts sector.

2. The following specific priorities:

- To contribute to further develop and put into practice the principles of good working conditions and fair remuneration for artists and cultural professionals based on the recommendations of the Report of the OMC group⁶ helping the sector to 'grow' in a social, human-centred, artistic, economic and environmental sense, with a long-term perspective.
- To incorporate activities that proactively reach out to people, both performing arts professionals and audiences, from different geographical and socio-economic backgrounds, including the younger generation, in order to ensure their equal access to distribution opportunities and a diverse artistic offer.

This action complements the other initiatives or actions under Creative Europe supporting the performing arts sector within the **EU policies and the performing arts sector**⁷: the first iteration of Perform Europe over the period 2023-2026⁸ and the European Theatre Initiative⁹. Applicants are encouraged to look for synergies between them.

The projects should be based on the principles of good working conditions and fair remuneration of artists and cultural professionals and respect national standards and follow best practices, referring to and using, the Report of the Open Method of Coordination (OMC) group of EU Member States' experts "The status and working conditions of artists and cultural and creative professionals"¹⁰ and the "Mutual learning workshop on Access to social protection for artists" report"¹¹. Further useful information on this subject is available on the Creatives Unite website¹². Artists and cultural professionals should be given recognition and visibility, in particular, by being credited on all printed and online communication and dissemination material.

Activities that can be funded (scope)

Applications must present a programme of activities that will develop, implement and maintain sustainable models for cross-border touring and digital distribution in the performing arts sector.

They must include at least the 6 following types of activities:

1. The management and the coordination of the overall project;
2. The design, implementation and management of open call(s) to select and regrant at least 25 projects to support cross-border touring and digital distribution of performing arts works. These projects will be managed under the provisions of “financial support to third parties” (see section 6 below - Eligible activities) and implemented in the countries participating in the Creative Europe Programme (see section 6 below);
3. The development of a programme of support and assistance to the grant recipients including training, mentorship and capacity building;
4. The maintenance and the development of the **Perform Europe** digital platform developed under the first iteration of the action¹³ in order to:
 - a. collect data, explore, map and analyse how performing arts works are presented across borders;
 - b. foster networking and matchmaking and bring visibility to performing and distribution opportunities;
5. The development and the implementation of a communication, dissemination and branding strategy both for the project and for the artists and cultural professionals;
6. The analysis: gathering and dissemination of data: reports on how to ensure good working conditions and fair remuneration in practice; data on the projects and their results, etc.

Under this call for proposals, financial support to third parties is essential to address the type of activity 2 (above). For more details see section 6 (Eligibility - *Eligible activities*).

Expected impact

This call for proposals will select one single project which will regrant a minimum of 25 projects from all performing arts sub-sectors and disciplines.

The selected project should observe, and analyse the results of the projects which have been selected for granting and publish analysis reports which should include topics such as artists’ working conditions and fair remuneration, sustainable touring routes, inclusion, skills, employment, professions, artistic creation, youth, etc.

3. Available budget

The estimated available call budget is **EUR 2 000 000**.

The availability of the call budget still depends on the final adoption of the budget 2026 by the EU budgetary authority.

At least 70% of the total budget of this call, should be spent in financial support to third parties.

We reserve the right not to award all available funds or to redistribute them between the call priorities, depending on the proposals received and the results of the evaluation.

5. Admissibility and documents

Proposals must be submitted before the **call deadline** (see *timetable section 4*).

Proposals must be submitted **electronically** via the Funding & Tenders Portal Electronic Submission System (accessible via the Topic page in the [Calls for proposals](#) section. Paper submissions are NOT possible.

Proposals (including annexes and supporting documents) must be submitted using the forms provided *inside* the Submission System (⚠ NOT the documents available on the Topic page — they are only for information).

Proposals must be **complete** and contain all the requested information and all required annexes and supporting documents:

- Application Form Part A — contains administrative information about the participants (future coordinator, beneficiaries and affiliated entities) and the summarised budget for the project (*to be filled in directly online*)

- Application Form Part B — contains the technical description of the project (*template to be downloaded from the Portal Submission System, completed, assembled and re-uploaded*)
- Part C — contains additional project data and the project's contribution to EU programme key performance indicators (*to be filled in directly online*)
- **mandatory annexes and supporting documents** (*templates to be downloaded from the Portal Submission System, completed, assembled and re-uploaded*):
 - detailed budget table/calculator
 - CVs (standard) of core project team
 - activity reports of last year: not applicable
 - list of previous projects (key projects for the last 4 years) (*template available in Part B*)

Please be aware that since the detailed budget table serves as the basis for fixing the lump sums for the grants (and since lump sums must be reliable proxies for the actual costs of a project), the costs you include **MUST** comply with the basic eligibility conditions for EU actual cost grants (see [AGA — Annotated Grant Agreement, art 6](#)). This is particularly important for purchases and subcontracting, which must comply with best value for money (or if appropriate the lowest price) and be free of any conflict of interests. If the budget table contains ineligible costs, the grant may be reduced (even later on during the project implementation or after their end).

At proposal submission, you will have to confirm that you have the **mandate to act** for all applicants. Moreover, you will have to confirm that the information in the application is correct and complete and that all participants comply with the conditions for receiving EU funding (*especially eligibility, financial and operational capacity, exclusion, etc*). Before signing the grant, each beneficiary and affiliated entity will have to confirm this again by signing a declaration of honour (DoH). Proposals without full support will be rejected.

Your application must be **readable, accessible and printable** (please check carefully the layout of the documents uploaded).

Proposals are limited to maximum **70 pages** (Part B). Evaluators will not consider any additional pages.

You may be asked at a later stage for further documents (*for legal entity validation, financial capacity check, bank account validation, etc*).

6. Eligibility

Eligible participants (eligible countries)

In order to be eligible, the applicants (beneficiaries and affiliated entities) must:

- be legal entities (public or private bodies)
- be established in one of the eligible countries, i.e.:
 - Creative Europe Participating Countries:
 - EU Member States (including overseas countries and territories)

(OCTs))

- non-EU countries:
 - listed EEA countries and countries associated to the Creative Europe Programme ([list of participating countries](#))

Beneficiaries and affiliated entities must register in the [Participant Register](#) — before submitting the proposal — and will have to be validated by the Central Validation Service (REA Validation). For the validation, they will be requested to upload documents showing legal status and origin.

Other entities may participate in other consortium roles, such as associated partners, subcontractors, third parties giving in-kind contributions, etc (*see section 13*).

Specific cases and definitions

Natural persons — Natural persons are NOT eligible (with the exception of self-employed persons, i.e. sole traders, where the company does not have legal personality separate from that of the natural person.

International organisations — International organisations are eligible. The rules on eligible countries do not apply to them.

Entities without legal personality — Entities which do not have legal personality under their national law may exceptionally participate, provided that their representatives have the capacity to undertake legal obligations on their behalf, and offer guarantees for the protection of the EU financial interests equivalent to that offered by legal persons¹⁴.

EU bodies — EU bodies (with the exception of the European Commission Joint Research Centre) can NOT be part of the consortium.

Associations and interest groupings — Entities composed of members may participate as 'sole beneficiaries' or 'beneficiaries without legal personality'¹⁵. ⚠ Please note that if the action will be implemented by the members, they should also participate (either as beneficiaries or as affiliated entities, otherwise their costs will NOT be eligible).

Countries currently negotiating association agreements — Beneficiaries from countries with ongoing negotiations for participation in the programme (*see list of participating countries above*) may participate in the call and can sign grants if the negotiations are concluded before grant signature and if the association covers the call (i.e. is retroactive and covers both the part of the programme and the year when the call was launched).

EU restrictive measures — Special rules apply for entities subject to [EU restrictive measures](#) under Article 29 of the Treaty on the European Union (TEU) and Article 215 of the Treaty on the Functioning of the EU (TFEU)¹⁶. Such entities are not eligible to participate in any capacity, including as beneficiaries, affiliated entities, associated partners, subcontractors or recipients of financial support to third parties (if any).

EU conditionality measures — Special rules apply for entities subject to measures adopted on the basis of EU Regulation 2020/2092¹⁷. Such entities are not eligible to participate in any funded role (beneficiaries, affiliated entities, subcontractors, recipients of financial support to third parties, etc). Currently such measures are in place for Hungarian public interest trusts established under the Hungarian Act IX of 2021 or any entity they maintain (see [Council Implementing Decision \(EU\) 2022/2506](#), as of 16 December 2022).

Consortium composition

Proposals must be submitted by a single applicant or by a consortium of at least 3 applicants (beneficiaries; not affiliated entities).

Eligible activities

Applications will only be considered eligible if their content corresponds wholly (or at least in part) to the topic description for which they are submitted.

Eligible activities are the ones set out in section 2 above.

Projects must comply with EU policy interests and priorities. Projects must also respect EU values and European Commission policy regarding reputational matters (e.g. *activities involving capacity building, policy support, awareness raising, communication, dissemination, etc*).

Financial support to third parties is allowed for grants or similar forms of support under the following conditions:

- the calls must be open, published widely and conform to EU standards concerning transparency, equal treatment, conflict of interest and confidentiality
- the outcome of the call must be published on the participants' websites, including a description of the selected projects, award dates, project durations, and final recipient legal names and countries
- the calls must have a clear European dimension.

Your project application must clearly specify why financial support to third parties is needed, how it will be managed and provide a list of the different types of activities for which a third party may receive financial support. The proposal must also clearly describe the results to be obtained (see *section 2 - Activities that can be funded (scope)*).

In addition, financial support to third parties (FSTP) will be accepted in projects if they respect the following conditions:

- The use of at least 70% of the grant available for the FSTP (see *section 3 - Available budget*);

- The maximum amount of financial support that can be paid to a third party shall not exceed EUR 60 000;
- The outcomes of the call(s) must be published on the EU Funding & Tenders Portal:
 - For the sub-calls published you need to be able to provide the following data: call reference, call budget, budget awarded, call publication date, call closure date, URL to F&T portal, call status, number of received proposals, number of awarded proposals;
 - For the awarded beneficiaries you need to be able to provide the following data: call reference, PIC (if available), legal name, organisation type, country, funding awarded, funding paid, comment (info of each project: name of each project; members of the project partnership for touring with PIC (if available), legal name, organisation type, country; start date and end date of each selected project; a short description of each selected project and a link to the project's website(s) and social media).
- Activities carried out by third parties must be completed during the period covered by the Grant Agreement. Only costs incurred during that period can be considered eligible.
- The proposals submitted by third parties should demonstrate that the applicant will put in place a solid management and control system to ensure that the principles of economy, efficiency and effectiveness are respected.

Duration

Projects should not normally exceed 24 months.

Extensions are possible, if duly justified and through an amendment.

Ethics

Projects must comply with:

- highest ethical standards and
- applicable EU, international and national law.

They may not include pornographic or racist material or advocate violence.

7. Financial and operational capacity and exclusion

Financial capacity

Applicants must have **stable and sufficient resources** to successfully implement the projects and contribute their share. Organisations participating in several projects must have sufficient capacity to implement all projects.

The financial capacity check will be carried out on the basis of the documents you will be requested to upload in the [Participant Register](#) during grant preparation (*e.g. profit and loss account and balance sheet, business plan, audit report produced by an approved external auditor, certifying the accounts for the last closed financial year, etc*). The analysis will be based on neutral financial indicators, but will also take into account other aspects, such as dependency on EU funding and deficit and revenue in previous years.

The check will normally be done for coordinators, except:

- public bodies (entities established as public body under national law, including local, regional or national authorities) or international organisations
- entities active in cultural and creative sectors that have received over 50% of their annual revenue from public sources over the last two years
- if the project requested grant amount is not more than EUR 60 000.

If needed, it may also be done for affiliated entities.

If we consider that your financial capacity is not satisfactory, we may require:

- further information
- an enhanced financial responsibility regime, i.e. joint and several responsibility for all beneficiaries or joint and several liability of affiliated entities (*see below, section 10*)
- prefinancing paid in instalments
- (one or more) prefinancing guarantees (*see below, section 10*)

or

- propose no prefinancing
- request that you are replaced or, if needed, reject the entire proposal.

Operational capacity

Applicants must have the **know-how, qualifications** and **resources** to successfully implement the projects and contribute their share (including sufficient experience in projects of comparable size and nature).

This capacity will be assessed together with the 'Project Management' award criterion, on the basis of the competence and experience of the applicants and their project teams, including operational resources (human, technical and other) or, exceptionally, the measures proposed to obtain it by the time the task implementation starts.

If the evaluation of the award criterion is positive, the applicants are considered to have sufficient operational capacity.

Applicants will have to show their capacity via the following:

- general profiles (qualifications and experiences) of the staff responsible for managing and implementing the project
- description of the consortium participants
- list of previous projects (key projects for the last 4 years) (*template available in Part B*).
- the CVs of the core project team (*to be uploaded*)

Additional supporting documents may be requested, if needed to confirm the operational capacity of any applicant.

Public bodies, Member State organisations, international organisations and entities active in cultural and creative sectors that have received over 50% of their annual

revenue from public sources over the last two years are exempted from the operational capacity check.

Exclusion

Applicants which are subject to an **EU exclusion decision** or in one of the following **exclusion situations** that bar them from receiving EU funding can NOT participate¹⁸:

- bankruptcy, winding up, affairs administered by the courts, arrangement with creditors, suspended business activities or other similar procedures (including procedures for persons with unlimited liability for the applicant's debts)
- in breach of social security or tax obligations (including if done by persons with unlimited liability for the applicant's debts)
- guilty of grave professional misconduct¹⁹ (including if done by persons having powers of representation, decision-making or control, beneficial owners or persons who are essential for the award/implementation of the grant)
- committed fraud, corruption, links to a criminal organisation, money laundering, terrorism-related crimes (including terrorism financing), child labour or human trafficking (including if done by persons having powers of representation, decision-making or control, beneficial owners or persons who are essential for the award/implementation of the grant)
- shown significant deficiencies in complying with main obligations under an EU procurement contract, grant agreement, prize, expert contract, or similar (including if done by persons having powers of representation, decision-making or control, beneficial owners or persons who are essential for the award/implementation of the grant)
- guilty of irregularities within the meaning of Article 1(2) of EU Regulation [2988/95](#) (including if done by persons having powers of representation, decision-making or control, beneficial owners or persons who are essential for the award/implementation of the grant)
- created under a different jurisdiction with the intent to circumvent fiscal, social or other legal obligations in the country of origin or created another entity with this purpose (including if done by persons having powers of representation, decision-making or control, beneficial owners or persons who are essential for the award/implementation of the grant)
- intentionally and without proper justification resisted²⁰ an investigation, check or audit carried out by an EU authorising officer (or their representative or auditor), OLAF, the EPPO, or the European Court of Auditors.

Applicants will also be rejected if it turns out that²¹:

- during the award procedure they misrepresented information required as a condition for participating or failed to supply that information
- they were previously involved in the preparation of the call and this entails a distortion of competition that cannot be remedied otherwise (conflict of interest).

8. Evaluation and award procedure

The proposals will have to follow the **standard submission and evaluation procedure** (one-stage submission + one-step evaluation).

An **evaluation committee** (assisted by independent outside experts) will assess all applications. Proposals will first be checked for formal requirements (admissibility, and eligibility, *see sections 5 and 6*). Proposals found admissible and eligible will be evaluated (for each topic) against the operational capacity and award criteria (*see sections 7 and 9*) and then ranked according to their scores.

For proposals with the same score (within a topic) a **priority order** will be determined according to the following approach:

Successively for every group of *ex aequo* proposals, starting with the highest scored group, and continuing in descending order:

- 1) The *ex aequo* proposals within the same topic will be prioritised according to the scores they have been awarded for the award criterion 'Relevance'. When these scores are equal, priority will be based on their scores for the criterion 'Dissemination'. When these scores are equal, priority will be based on their scores for the criterion 'Quality of content and activities'.
- 2) If this does not allow to determine the priority, a further prioritisation can be done by considering the overall project portfolio and the creation of positive synergies between projects, or other factors related to the objectives of the call. These factors will be documented in the panel report.

All proposals will be informed about the evaluation result (**evaluation result letter**). Successful proposals will be invited for grant preparation; other ones will be put on the reserve list or rejected.

 No commitment for funding — Invitation to grant preparation does NOT constitute a formal commitment for funding. We will still need to make various legal checks before grant award: *legal entity validation, financial capacity, exclusion check, etc.*

Grant preparation will involve a dialogue in order to fine-tune technical or financial aspects of the project and may require extra information from your side. It may also include adjustments to the proposal to address recommendations of the evaluation committee or other concerns. Full compliance will be a pre-condition for signing the grant.

If you believe that the evaluation procedure was flawed, you can submit a **complaint** (following the deadlines and procedures set out in the evaluation result letter). Please note that notifications which have not been opened within 10 days after sending will be considered to have been accessed and that deadlines will be counted from opening/access (*see also [Funding & Tenders Portal Terms and Conditions](#)*). Please also be aware that for complaints submitted electronically, there may be character limitations.

9. Award criteria

The **award criteria** for this call are as follows:

1. Relevance:

This criterion will consider the extent to which the proposal:

- is relevant to the objectives and specific priorities of the call as well as to the EU overarching priorities,
- is based on a sound and adequate needs analysis,
- is complementary with other actions at local, national, or European level, innovates and provides European added value.

(25 points)

2. Quality of content and activities:

This criterion will consider the extent to which:

- the proposed concept and methodologies are appropriate to achieve the project's objectives.
- the target groups will benefit from the project and its effects.
- the project design is consistent and coherent, and feasible within the proposed time frame.
- the distribution strategy has the potential to ensure an easy access to the performing arts works.

(30 points)

3. Project management:

This criterion will consider the extent to which:

- the proposal includes effective mechanisms for coordination between the participating organisations and proposes an adequate management of the activities.
- the project budget is cost effective (best value for money) and allocates appropriate resources to each activity particularly to the artists and cultural professionals in order to respect the principles of good working conditions and fair remuneration.
- the proposal involves the appropriate project teams, staff, and outside resources (including know-how, qualifications, and resources), to successfully implement the project.

(25 points)

4. Dissemination:

This criterion will consider the extent to which:

- the project applies best practices or triggers change and innovation.
- the communication and dissemination strategies have the potential to reach new audiences, including young audiences, and positively impact the target groups, participating organisations and the wider community and they also must include the visibility of the EU support.
- the proposal includes concrete and effective steps to ensure the sustainability of the project and to produce results after the end of the action.

(20 points)

Award criteria	Minimum pass score	Maximum score
Relevance	13	25
Quality of content and activities	15	30
Project management	13	25
Dissemination	10	20
Overall (pass) scores	70	100

Maximum points: 100 points.

Individual thresholds per criterion: 13/25, 15/30, 13/25 and 10/20 points.

Overall threshold: 70 points.

Proposals that pass the individual thresholds AND the overall threshold will be considered for funding — within the limits of the available budget (i.e. up to the budget ceiling). Other proposals will be rejected.

10. Legal and financial set-up of the Grant Agreements

If you pass evaluation, your project will be invited for grant preparation, where you will be asked to prepare the Grant Agreement together with the EU Project Officer.

This Grant Agreement will set the framework for your grant and its terms and conditions, in particular concerning deliverables, reporting and payments.

The Model Grant Agreement that will be used (and all other relevant templates and guidance documents) can be found on [Portal Reference Documents](#).

Starting date and project duration

The project starting date and duration will be fixed in the Grant Agreement (*Data Sheet, point 1*). Normally the starting date will be after grant signature. A retroactive starting date can be granted exceptionally for duly justified reasons — but never earlier than the proposal submission date.

Project duration: *see section 6 above*.

Milestones and deliverables

The milestones and deliverables for each project will be managed through the Portal Grant Management System and will be reflected in Annex 1 of the Grant Agreement.

Each work package should have at least 1 deliverable, but it is highly recommended to have more than 1 deliverable.

All deliverables should illustrate the scope, reach, progress, and success of the proposed activities.

The project activities must be organised in the following work packages:

WP1 - Project management and coordination for the coordinating organisation (mandatory)

- This work package should include the management, planning, administration, and evaluation activities of the project.
- **Activities** of this work package might include meetings, evaluation, coordination and quality control activities, strategy development, preparation of reports, etc.
- **Deliverables** of this work package might include agendas or minutes of meetings, evaluation and/or quality control reports, a set of indicators for the assessment of activities and their impact, conception/planning reports, etc.

WP2 - Design, implementation and management of a call or calls for projects for cross-border touring and digital distribution of performing arts works in Creative Europe countries (mandatory)

- This work package should include activities of design, implementation and management of call(s) for projects for cross-border touring and digital distribution of performing arts works in Creative Europe countries and help reach new and wider audiences. The open call(s) for projects must select minimum 25 projects.
- **Activities** of this work package might include design of the call(s) for projects, publication of the call(s), the evaluation and selection of projects applications, and monitoring.
- **Deliverables** of this work package might include agenda or minutes of meetings, evaluation and/or quality control reports, evaluation criteria for the consideration of the cross-cutting issues, evaluation process and rules, webpage with information on the call(s) for projects and notably the selection of the projects, funded projects performance report(s), audience development report(s), feedback from participants, thematic analysis or reports, report(s) on the impact on the career of the participants and the works, etc.

WP3 – The development of a programme of support and assistance to recipients of the cascading grants (mandatory).

- This work package should include **activities** of training, mentorship and capacity building.
- **Deliverables** of this work package might include agendas or minutes of meetings, training and mentorship programmes, and/or workshops, masterclasses, tutorials, feedback from participants, evaluation report of the support and assistance programmes/activities, etc.

WP4 – Development and maintenance of the *Perform Europe* digital platform for performing arts professionals in the context of cross-border touring and digital distribution of works (mandatory)

- This work package should include **activities** of maintenance and development of the ***Perform Europe*** digital platform with technical features enabling collection of data, networking and matchmaking. The platform should be dynamic, user friendly and support collaboration and engagement.
- **Deliverables** of this work package might include agenda or minutes of meetings, requirements specifications, reports on the implementation, evaluation and/or quality control reports, analytics and infographics reports, feedback from the platform users and administrators (interaction with content, perspectives for further improvements and developments...), etc.

WP5 – Communication, dissemination and branding (mandatory)

- This work package should group the activities aiming at ensuring adequate visibility of the activities of the project and the ***Perform Europe*** branding.
- **Activities** of this work package might include communication activities to ensure the visibility of ***Perform Europe*** as well as the call(s) for projects, the projects selected, and the artists and cultural professionals involved with a wide dissemination of the results beyond local, regional and national levels.
- In addition to the communication and dissemination regular **activities**, this work package could group **activities** aiming at developing, implementing and establishing the brand of ***Perform Europe*** through narratives and storytelling involving performing arts artists and professionals and making use of the data collected by all participating organisations all along the project implementation.
- **Deliverables** of this work package might include a communication and dissemination strategy, collection of data on the cascading grant projects in a consolidated way, communication/dissemination events and campaigns, promotion of projects, production of communication/dissemination material, advertising and branding strategy and materials (concept paper, brochures, programmes,

posters, banners, tag lines, mission statements, graphic design specifications, logo, etc.), press reviews, etc.

WP6 - Networking and sharing of knowledge and practices (mandatory)

- The activities under this work package should target organisations, artists and professionals from the performing arts sector that can meet, exchange and network.
- This work package could group networking and knowledge sharing **activities**, including research/innovation activities for the performing arts sector.
- **Activities** of this work package might include conferences, workshops, symposia, seminars, research, studies, analysis, surveys, laboratories, market access activities, etc.
- **Deliverables** of this work package might include networking development strategies; Europe-wide and sector(s)-specific online/on-site conferences reports; report(s) on exchange programmes across organisations, report(s) on the development, testing and production of networking or matchmaking tool, report(s) on touring and programming /brokerage and market-access events (matchmaking events, pitching sessions or B2B meetings), reports on laboratories, festivals and fairs, analysis of surveys, study papers, analysis, thematic reports, papers etc.

Additional work packages may be added.

Form of grant, funding rate and maximum grant amount

The grant parameters (*maximum grant amount, funding rate, total eligible costs, etc*) will be fixed in the Grant Agreement (*Data Sheet, point 3 and art 5*).

Project budget (requested grant amount): max EUR 2 000 000 per project.

The grant will be a lump sum grant. This means that it will reimburse a fixed amount, based on a lump sum or financing not linked to costs. The amount will be fixed by the granting authority on the basis of the estimated project budget and a funding rate of **90%**.

Budget categories and cost eligibility rules

The budget categories and cost eligibility rules are fixed in the Grant Agreement (*Data Sheet, point 3, art 6 and Annex 2*).

Budget categories for this call:

- Lump sum contributions²²

Specific cost eligibility rules for this call:

- the lump sum amount must be calculated in accordance with the methodology set out in the lump sum decision and using the detailed budget table/calculator provided (if any)
- the lump sum calculation should respect the following conditions:
 - for lump sums based on estimated project budgets: the estimated budget must comply with the basic eligibility conditions for EU actual cost grants (see [AGA — Annotated Grant Agreement, art 6](#))
 - for lump sums based on estimated project budgets: costs for financial support to third parties: must be included in the detailed budget table for grants or similar; maximum amount per third party EUR 60 000.

Reporting and payment arrangements

The reporting and payment arrangements are fixed in the Grant Agreement (*Data Sheet, point 4 and art 21 and 22*).

After grant signature, you will normally receive a **prefinancing** to start working on the project (float of normally **80%** of the maximum grant amount; exceptionally less or no prefinancing). The prefinancing will be paid 30 days from entry into force/financial guarantee (if required) — whichever is the latest.

There will be no interim payments. There will be one or more **additional prefinancing** payments linked to a prefinancing report.

Payment of the balance: At the end of the project, we will calculate your final grant amount. If the total of earlier payments is higher than the final grant amount, we will ask you (your coordinator) to pay back the difference (recovery).

All payments will be made to the coordinator.

 Please be aware that payments will be automatically lowered if you or one of your consortium members has outstanding debts towards the EU (granting authority or other EU bodies). Such debts will be offset by us — in line with the conditions set out in the Grant Agreement (see *art 22*).

Please also note that you are responsible for **keeping records** on all the work done.

Prefinancing guarantees

If a prefinancing guarantee is required, it will be fixed in the Grant Agreement (*Data Sheet, point 4*). The amount will be set during grant preparation, and it will normally be equal to or lower than the prefinancing for your grant.

The guarantee should be in euro and issued by an approved bank/financial institution established in an EU Member State. If you are established in a non-EU country and would like to provide a guarantee from a bank/financial institution in your country, please contact us (this may be exceptionally accepted, if it offers equivalent security).

Amounts blocked in bank accounts will NOT be accepted as financial guarantees.

Prefinancing guarantees are normally requested from the coordinator, for the consortium. They must be provided during grant preparation, in time to make the prefinancing (scanned copy via Portal AND original by post).

If agreed with us, the bank guarantee may be replaced by a guarantee from a third party.

The guarantee will be released at the end of the grant, in accordance with the conditions laid down in the Grant Agreement (*art 23*).

Certificates

Depending on the type of action, size of grant amount and type of beneficiaries, you may be requested to submit different certificates. The types, schedules and thresholds for each certificate are fixed in the Grant Agreement (*Data Sheet, point 4 and art 24*).

Liability regime for recoveries

The liability regime for recoveries will be fixed in the Grant Agreement (*Data Sheet, point 4.4 and art 22*).

For beneficiaries, it is one of the following:

- limited joint and several liability with individual ceilings — *each beneficiary up to their maximum grant amount*
 - unconditional joint and several liability — *each beneficiary up to the maximum grant amount for the action*
- or
- individual financial responsibility — *each beneficiary only for their own debts*.

In addition, the granting authority may require joint and several liability of affiliated entities (with their beneficiary).

Provisions concerning the project implementation

Non-compliance and breach of contract

The Grant Agreement (chapter 5) provides for the measures we may take in case of breach of contract (and other non-compliance issues).

11. How to submit an application

All proposals must be submitted directly online via the Funding & Tenders Portal Electronic Submission System. Paper applications are NOT accepted.

Submission is a **2-step process**:

a) create a user account and register your organisation

To use the Submission System (the only way to apply), all participants need to [create an EU Login user account](#).

Once you have an EULogin account, you can [register your organisation](#) in the Participant Register. When your registration is finalised, you will receive a 9-digit participant identification code (PIC).

b) submit the proposal

Access the Electronic Submission System via the Topic page in the [Calls for proposals](#) section (or, for calls sent by invitation to submit a proposal, through the link provided in the invitation letter).

Submit your proposal in 4 parts, as follows:

- Part A includes administrative information about the applicant organisations (future coordinator, beneficiaries, affiliated entities and associated partners) and the summarised budget for the proposal. Fill it in directly online
- Part B (description of the action) covers the technical content of the proposal. Download the mandatory word template from the Submission System, fill it in and upload it as a PDF file
- Part C containing additional project data. To be filled in directly online.
- Annexes (*see section 5*). Upload them as PDF file (single or multiple depending on the slots). Excel upload is sometimes possible, depending on the file type.

The proposal must keep to the **page limits** (*see section 5*); excess pages will be disregarded.

Documents must be uploaded to the **right category** in the Submission System, otherwise the proposal may be considered incomplete and thus inadmissible.

The proposal must be submitted **before the call deadline** (*see section 4*). After this deadline, the system is closed and proposals can no longer be submitted.

Once the proposal is submitted, you will receive a **confirmation e-mail** (with date and time of your application). If you do not receive this confirmation e-mail, it means your proposal has NOT been submitted. If you believe this is due to a fault in the Submission System, you should immediately file a complaint via the [IT Helpdesk webform](#), explaining the circumstances and attaching a copy of the proposal (and, if possible, screenshots to show what happened).

Details on processes and procedures are described in the [Online Manual](#). The Online Manual also contains the links to FAQs and detailed instructions regarding the Portal Electronic Exchange System.

Guidance on the use of generative AI tools for the preparation of the proposal

When considering the use of generative artificial intelligence (AI) tools for the preparation of the proposal, it is imperative to exercise caution and careful consideration. The AI-generated content should be thoroughly reviewed and validated by the applicants to ensure its appropriateness and accuracy, as well as its compliance with intellectual property regulations. Applicants are fully responsible for the content of the proposal (even those parts produced by the AI tool) and must be transparent in disclosing which AI tools were used and how they were utilised.

Specifically, applicants are required to:

- Verify the accuracy, validity, and appropriateness of the content and any citations generated by the AI tool and correct any errors or inconsistencies.
- Provide a list of sources used to generate content and citations, including those generated by the AI tool.
- Double-check citations to ensure they are accurate and properly referenced.
- Be conscious of the potential for plagiarism where the AI tool may have reproduced substantial text from other sources. Check the original sources to be sure you are not plagiarizing someone else's work.
- Acknowledge the limitations of the AI tool in the proposal preparation, including the potential for bias, errors, and gaps in knowledge.

13. Important



IMPORTANT

- **Don't wait until the end** — Complete your application sufficiently in advance of the deadline to avoid any last minute **technical problems**. Problems due to last minute submissions (*e.g. congestion, etc*) will be entirely at your risk. Call deadlines can NOT be extended.
- **Consult** the Portal Topic page regularly. We will use it to publish updates and additional information on the call (call and topic updates).
- **Funding & Tenders Portal Electronic Exchange System** — By submitting the application, all participants **accept** to use the electronic exchange system in accordance with the [Portal Terms & Conditions](#).
- **Registration** — Before submitting the application, all beneficiaries, affiliated entities and associated partners must be registered in the [Participant Register](#). The participant identification code (PIC) (one per participant) is mandatory for the Application Form.
- **Consortium roles** — When setting up your consortium, you should think of organisations that help you reach objectives and solve problems.

The roles should be attributed according to the level of participation in the project. Main participants should participate as **beneficiaries** or **affiliated entities**; other entities can participate as associated partners, subcontractors, third parties giving in-kind contributions. **Associated partners** and third parties giving in-kind contributions should bear their own costs (they will not become formal recipients of EU funding). **Subcontracting** should normally constitute a limited part and must be performed by third parties (not by one of the beneficiaries/affiliated entities). Subcontracting going beyond 30% of the total eligible costs must be justified in the application.

- **Coordinator** — In multi-beneficiary grants, the beneficiaries participate as consortium (group of beneficiaries). They will have to choose a coordinator, who will take care of the project management and coordination and will represent the consortium towards the granting authority. In mono-beneficiary grants, the single beneficiary will automatically be coordinator.
- **Affiliated entities** — Applicants may participate with affiliated entities (i.e. entities linked to a beneficiary which participate in the action with similar rights and obligations as the beneficiaries, but do not sign the grant and therefore do not become beneficiaries themselves). They will get a part of the grant money and must therefore comply with all the call conditions and be validated (just like beneficiaries); but they do not count towards the minimum eligibility criteria for consortium composition (if any). If affiliated entities participate in your project, please do not forget to provide documents demonstrating their affiliation link to your organisation as part of your application.
- **Associated partners** — Applicants may participate with associated partners (i.e. partner organisations which participate in the action but without the right to get grant money). They participate without funding and therefore do not need to be validated.
- **Consortium agreement** — For practical and legal reasons it is recommended to set up internal arrangements that allow you to deal with exceptional or unforeseen circumstances (in all cases, even if not mandatory under the Grant Agreement). The consortium agreement also gives you the possibility to redistribute the grant money according to your own consortium-internal principles and parameters (for instance, one beneficiary can reattribute its grant money to another beneficiary). The consortium agreement thus allows you to customise the EU grant to the needs inside your consortium and can also help to protect you in case of disputes.

- **Balanced project budget** — Grant applications must ensure a balanced project budget and sufficient other resources to implement the project successfully (*e.g. own contributions, income generated by the action, financial contributions from third parties, etc*). You may be requested to lower your estimated costs, if they are ineligible (including excessive).
- **Completed/ongoing projects** — Proposals for projects that have already been completed will be rejected; proposals for projects that have already started will be assessed on a case-by-case basis (in this case, no costs can be reimbursed for activities that took place before the project starting date/proposal submission).
- **No-profit rule** — Grants may NOT give a profit (i.e. surplus of revenues + EU grant over costs). This will be checked by us at the end of the project.
- **No cumulation of funding/no double funding** — It is strictly prohibited to cumulate funding from the EU budget (except under 'EU Synergies actions'). Outside such Synergies actions, any given action may receive only ONE grant from the EU budget and cost items may under NO circumstances be declared under two EU grants; projects must be designed as different actions, clearly delineated and separated for each grant (without overlaps).
- **Combination with EU operating grants** — Combination with EU operating grants is possible, if the project remains outside the operating grant work programme and you make sure that cost items are clearly separated in your accounting and NOT declared twice (see [AGA — Annotated Grant Agreement, art 6.2.E](#)).
- **Multiple proposals** — Applicants may submit more than one proposal for *different* projects under the same call (and be awarded funding for them). Organisations may participate in several proposals. BUT: if there are several proposals for *very similar* projects, only one application will be accepted and evaluated; the applicants will be asked to withdraw the others (or they will be rejected).
- **Resubmission** — Proposals may be changed and re-submitted until the deadline for submission.
- **Rejection** — By submitting the application, all applicants accept the call conditions set out in this Call document (and the documents it refers to). Proposals that do not comply with all the call conditions will be rejected. This applies also to applicants: All applicants need to fulfil the criteria; if any one of them doesn't, they must be replaced or the entire proposal will be rejected.
- **Cancellation** — There may be circumstances which may require the cancellation of the call. In this case, you will be informed via a call or topic update. Please note that cancellations are without entitlement to compensation.
- **Language** — You can submit your proposal in any official EU language (project abstract/summary should however always be in English). For reasons of efficiency, we strongly advise you to use English for the entire application. If you need the call documentation in another official EU language, please submit a request within 10 days after call publication (for the contact information, see *section 12*).

- **Transparency** — In accordance with Article 38 of the [EU Financial Regulation](#), information about EU grants awarded is published each year on the [Europa website](#).

This includes:

- beneficiary names
- beneficiary addresses
- the purpose for which the grant was awarded
- the maximum amount awarded.

The publication can exceptionally be waived (on reasoned and duly substantiated request), if there is a risk that the disclosure could jeopardise your rights and freedoms under the EU Charter of Fundamental Rights or harm your commercial interests.

- **Data protection** — The submission of a proposal under this call involves the collection, use and processing of personal data. This data will be processed in accordance with the applicable legal framework. It will be processed solely for the purpose of evaluating your proposal, subsequent management of your grant and, if needed, programme monitoring, evaluation and communication.
